### System description

The door assemblies are Single Leaf open in or open out, hinged on outer frame or mullion, cassette glazed with BS EN 1279-2 compliant IGU(s), laminated on one pane to P1A, Profile 22 PVC-U Outerframes, NanYa GRP or Doorstop slabs with Stormguard aluminium low threshold. Door classification D.

### Approved Hardware

Option one: ERA Challenger 3D adjustable hinges with Winkhaus STV-Trulock and Winkhaus keeps. Winkhaus or UAP 1\* cylinder with Armorshield 2\* cylinder protector or Ingenious Apex 3\* cylinder or UAP Kinetica 3\* cylinder and either Winkhaus Palladio xl lever/lever handle or Fab & Fix Balmoral lever/lever handle. Doors can be supplied with or without letterplate which meets the requirements of TS008 Enhanced Security Grade 2.

Option two: ERA Challenger 3D adjustable hinges with Ingenious Duplex 5 hook lock 1009, Ingenious door keep set 1141 (L/H centre) or 1141 (R/H centre) and 2 x Duplex hook keeps 1143 and Fab & Fix Balmoral lever/lever handle. Ingenious Apex 3\* cylinder or UAP Kinetica 3\* cylinder. Doors can be supplied with or without letterplate which meets the requirements of TS008 Enhanced Security Grade 2.
